If the item and/or the associated inventory/accessories are returned in an improper condition, or with damage that has not been there at the pickup an additional will be charged in addition to the rental fee. In this case, the tenant is permitted to provide evidence that the costs were not incurred at all or were significantly lower.

§4 Renter's obligations

- 4.1 The renter confirms that he has taken over the rental item in full and without defects in accordance with the above inventory list. (Existing damages must be recoded)
- 4.2 The renter is obliged to protect the item from excessive stress in every way.
- 4.3 The renter undertakes to compensate the lessor for any damage to the rental item that occurs during the rental period. This also applies to damage caused/responsible for third parties. The lessor hereby assigns parallel claims for damages against third parties to the renter.
- 4.4 Subletting of the rental item is not permitted.

§5 Pickup and return

- 5.1 When the item is handed over, a material inspection should be carried out. The completeness and, if applicable, condition of the item and its inventory/accessories should be checked using the above inventory list and certified accordingly. The renter can waive the material inspection if he certifies completeness without checking. The lessor then remains entitled to determine the current status according to his knowledge. When the item is handed over, the risk is transferred to the renter.
- 5.2 When the item is returned, a material inspection should be carried out. The completeness and, if applicable, condition of the item and its inventory/accessories must be checked using the above inventory list and certified accordingly. If the renter waives the material inspection when returning the item, the lessor is the sole inspector. In this case, he is entitled to identify any shortages and to make a binding assessment of the condition of the item and its inventory/accessories at his own discretion.
